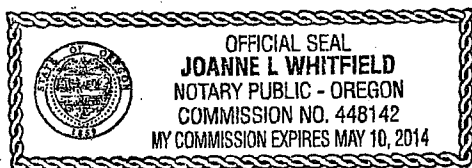

AFFIDAVIT OF PROBABLE CAUSE

Due to Clark's behavior and his continued efforts to trespass on a regular basis, Wells Fargo hired a security officer to stand guard and protect the safety of their employees.

On 072811 Clark was observed by employees approaching the bank on his bicycle. Schulke was advised that Clark came within one foot of the front doors of the business. Once Clark realized employees were watching him he left the area on his bicycle. Schulke was inside the bank, conducting his interview with bank employees; during that time, Clark again approached the bank. Clark appeared to notice Schulke inside the bank and again left the area eastbound on his bicycle. By the time Schulke exited the bank, Clark was gone.

Narrative

DETAILS:

On July 18th, 2011, at approximately 1600 hours, I was directed by Sergeant Klinko to do a welfare check on Andrew Glen Clark (DOB 08-08-58), and to advise him that he was Trespassed from all Wells Fargo properties, especially the downtown Eugene branch. Sergeant Klinko advised that Clark lived at 3270 Stoney Ridge Road, but was unsure if he still lived there. Sergeant Klinko said that Wells Fargo had fired Clark last month. He advised me that Clark had sent multiple emails to Wells Fargo, one that included a reference to genocide. He also advised that Wells Fargo told him Clark had pounded on the window of the downtown branch.

I went to 3270 Stoney Ridge Road and attempted contact at the front door. There was no answer. I went to the large windows to the left of the front door to look in and determine if the house appeared to be occupied. While looking in the windows, I heard the sound of someone shouting. I went back towards the front door and could see a male subject walking down the sidewalk towards the house asking if everything was okay. I recognized the subject to be Andrew Glen Clark from a picture that Sergeant Klinko had showed me. The subject identified himself as Andy and confirmed that his last name was Clark. Clark made several statements about being cooperative and willing to be placed under arrest if he did something wrong. He turned around and placed his hands behind his back as if assuming a position to be handcuffed. I told Clark that he was not under arrest and that I just needed to talk to him. When asked, Clark said he saw cops at his house, and just drove by and parked up the street because he was afraid of what could be going on at his house. He said he then walked down to the house and made contact with us. I told Clark that the nature of our contact was in regards to us checking his welfare and discussing some issues with Wells Fargo. Clark told me that he was glad we were there and had already been in contact with the FBI and the CIA about Wells Fargo. He indicated that he had a 100 page report he wanted us to look over. He also told me that Wells Fargo had been monitoring him via a camera placed in his computer. Clark invited us in to his house and we had a conversation with him at the table in his dining room.

I advised Clark that our conversation was being recorded. I told Clark that Wells Fargo had concerns about him and that I was notifying him that he was not allowed on Wells Fargo property anymore. I told Clark that Wells Fargo was concerned due to the emails they had received, specifically one that referenced genocide. I told him they were also concerned about him pounding on the window of the downtown Wells Fargo branch window.

Clark told me that he in no way meant the email to be threatening. He told me that he felt that him being fired made it feel like Wells Fargo was committing genocide on him. Clark told me that Wells Fargo had "asymmetrical" power. He told me that Wells Fargo was retaliating on him because he was a "whistle blower." Clark said that he had a 12 page report that I could look over to see all the wrong doings of Wells Fargo. I told him that I did not need to read the report, that I was just there to advise him if he

went onto Wells Fargo property, that he would be arrested and charged with trespassing. Clark was upset about being trespassed from Wells Fargo property. He argued his right to walk on the public property sidewalks in front of Wells Fargo property. Clark further explained that he would just keep calling and emailing Wells Fargo telling them how he was going to expose all of their wrong doings. I advised that Wells Fargo would appreciate him not emailing them anymore, especially due to the fact that they felt some were threatening. Clark told me that they misunderstood his emails. He also told me that he had not pounded on the windows of Wells Fargo. He told me that someone inside waved to him, and he just waved back at him in a friendly gesture. Later in the conversation, Clark told me that he wasn't on Wells Fargo property until the security guard and branch manager waved him over. He said one of them was named Eric and they had a friendly conversation. Even later in conversation with Clark, he said that he was the victim because Eric and the other guy weren't very nice to him.

I confirmed with Clark that all his needs were being met. Clark said that he owned his house outright, had plenty of money in the bank, and that he was healthy and fit. Clark said he needed nothing. Clark denied the need to speak to any counselors or anyone for support. Upon questioning, Clark said that he felt no desire to harm himself or others. He denied any suicidal ideology. Clark said that he has never and would never harm anyone else. In our conversation, he said he owned a pellet gun, but no firearms. He further explained that people had the right to own guns, but he thought they should make ammunition illegal to make the community safer.

Clark said he did not think Wells Fargo should be allowed to be concerned about his welfare and that it was a misuse of city funds to have us check on him. I tried explaining several times that I had two reasons for contacting him. That I wanted to check his welfare, and also to inform him that he was trespassed from all Wells Fargo properties. Clark tried to explain to me how I was a pawn and that Wells Fargo was using me at their will and that I should not be at his house checking his welfare or advising him he was trespassed from Wells Fargo. Clark explained again that Wells Fargo was using every means available to retaliate against him because he was trying to expose all of their wrong doings. Clark again told me that Wells Fargo had placed him under surveillance using a camera in his computer. He said that after he realized he was being surveilled, he put on a show for them for some time. He said something to the effect of, after all, it is Eugene and it is my house.

I confirmed again that Clark was not allowed to go on Wells Fargo property. I had to further explain Wells Fargo could take further action precluding him from calling or emailing if he continued in his current course of action with them. Clark walked out with us so he could retrieve his car and bring it back to his house. His car is a 2003 white Ford hatchback with Oregon license plate ZXC605. Clark gave me his phone numbers of (541) 510-3915, and (541) 343-2667. I left the residence and filled out a Field Interview card documenting my contact with Clark.

At approximately 1800, I was contacted by dispatch advising that Clark was at the front counter at City Hall wishing to speak to me again about our contact and to file charges against Wells Fargo for them filing a false police report.

Upon arrival at City Hall, Clark had a brief memo indicating he wanted Wells Fargo to be charged with filing a false police report against him. He also had a few other papers with him to include the emails between he and Wells Fargo. I explained to Clark the laws and elements for filing a false police report. I also explained to him that any business had the right to notify someone they were trespassed from their property. At the same time, anyone could be concerned about someone else's welfare. Clark told me that he felt violated by having the police at his house and embarrassed at what the neighbors might think. He thought it was an extreme intrusion on his privacy and did not think it acceptable that Wells Fargo could have police advise him he was trespassed from their property, regardless of the circumstances. He then went on another long discourse of how he was the victim of Wells Fargo's retaliation for him doing the right thing and exposing their wrong doings. He also explained repeatedly how he believed it was a misuse of the police department to have me doing Wells Fargo's dirty work.

I was not able to convince Clark that Wells Fargo violated no laws in trespassing him from their property. After explanation, I was unable to convince Clark that it was commonplace for police to do welfare checks on people. I was also unable to convince Clark that Wells Fargo violated no laws in regards to filing a false police report. Clark then asked to speak to my supervisor. I told Clark that my supervisor

was Officer Pieske who was there with us during the contacts and told Clark that Officer Pieske concurred with my findings in the matters. I asked Clark if there was anything else I could do for him. Clark said there was nothing else I could do for him and he left city hall.

Also per Sergeant Klinko's request, I contacted Marty Ogno, head of security for Wells Fargo. I called Ogno and told him I had contacted Clark and that he had been advised he was trespassed from all Wells Fargo properties. I also told Ogno Clark was concerned he had \$24,000 in an account at Wells Fargo. Ogno said he had looked it up and though Clark only had about \$200 in an account, but that he would close Clark's account and mail him a check with the remaining balance. Ogno asked how the contact went. I told Ogno that Clark felt he was being retaliated upon for contacting the FBI and CIA with Wells Fargo's wrong doings. Ogno said that he had been in contact with the FBI and told me that the FBI did not take Clark's reports seriously.

At approximately 1900 hours, dispatch advised that Clark had left a phone number for me to call him back so he could further discuss his desire to press charges against Wells Fargo for filing a false police report. I requested Sergeant Magnuson respond to the report writing room where I was working on reports so I could discuss the situation with him before calling Clark back. While I was explaining the situation to Sergeant Magnuson, Dispatch advised that Clark had called back 3 more times requesting contact. I then asked Sergeant Magnuson if he would contact Clark in my behalf in that I was unable to effectively communicate to Clark that Wells Fargo had broken no laws and that they had the right to trespass Clark from their properties.

I responded to Wells Fargo Mortgage at 100 E Broadway regarding a trespass complaint.

I contacted Christiansen and Potter. Christiansen is a security guard hired by Wells Fargo because of safety concerns about a former employee, Clark. Potter is a mortgage consultant in the office. They told me that Clark had recently (weeks ago) been terminated from his position at the office and had been repeatedly trying to come back in and entering back onto the property.

Potter said that Clark has, for several months, been demonstrating increasingly bizarre behavior. He described behavior that can be generalized as conspiratorial, neurotic, and obsessive. He said that he is turning the organization into the FBI for prosecution under the RICO statute. He said that he will rape his bosses because they fired him. He has continually come back and tapped on the windows and opened the front doors of the business after being told not to enter the premises.


Both Potter and Christiansen told me that they have authority to trespass people from the premises and they have done so with Clark via police contact. (on 071811, Officer Esch contacted Clark and told him that he was not allowed on any Wells Fargo Property – this was documented in an FI)

Because of Clark's behavior which resembles psychosis, Wells Fargo hires Christiansen as a guard for the safety of the workers there. On the above date and time, Christiansen and Potter told me that they saw Clark ride up on his bike and approach the doors of the business to within one foot of the doors. The business is on a corner and this would clearly be on the business property. He left when he saw he was being observed. As they were relating this to me, we all observed Clark approach the same corner on his bike. He appeared to observe me inside and rode off eastbound. By the time I could get out of the building, he was gone.


Potter and Christiansen both told me that the manager, Martin, has formally trespassed him from the location. Martin did not answer his phone. They said that they wanted him arrested for trespass.

I attempted to call Clark but he would not answer his phone.

The employees whom I spoke to were very concerned for their safety. They asked if they should carry guns to protect themselves from Clark should he return. They describe him as very mentally unstable and unpredictable.

In early July I was contacted my Martin Ogno whom is with Wells Fargo Corporate Security out of Portland. He wanted to advise me of a potential work place violence situation regarding a terminated employee, Andy Clark, and ask me questions about how Wells Fargo could proceed.

Ogno told me Clark was terminated for what he termed increasingly bizarre behavior directed toward co-workers, possibly as a result of a mental health problem. He said Clark was continuing to harass Wells Fargo employees both by e-mail and in person at him former place of employment. Ogno said Clark's erratic behavior was having a negative impact on the working environment of current Wells Fargo employees.

Ogno asked about obtaining a restraining order, to which I explained how those orders were typically reserved for individuals involved in romantic relationships. He also had questions about a lap top computer which Clark was reportedly refusing to return. In the end, it was decided by Ogno that he would continue to monitor the situation, but did not wish police intervention at that time. Given the potential for a work place violence incident, I did put information about Clark, including his DMV photograph, on a police only site for information sharing, so officers working in the downtown area, would be aware of a potential problem.

As Clark's behavior escalated, according to Ogno, both in terms of e-mails to Wells Fargo employees and site visits to the downtown office, I continued to converse with Ogno, answering questions and trying to give direction.

On July 18th I spoke with Ogno by phone. He told me of Clark reportedly showing up at the downtown branch and banging on exterior windows, causing great alarm to employees. He said he also had yet to recover the lap top computer that had been assigned to Clark. Ogno told me he would both like officers to check the welfare of Clark, whose bizzare behavior seemed to be escalating, and officially inform him he was trespassed from any and all Wells Fargo institutions. Given the situation, I agreed to have officers do so.

I directed Sgt. Magnuson to have two officers check on Clark's welfare and to advise him not to return to Wells Fargo property without explicit permission from Martin Ogno or other representatives. Because of this contact, and the information I had previously disseminated about the potential for work place violence, Agent Shulke, whom works downtown on a bicycle, was aware of Clark and the situation. It was this knowledge which led him to have contact at Wells Fargo on July 29th, where he document an incident of trespass, which subsequently led to Clark's arrest by Officer Te'o.

I have had no contact directly with Clark nor recent contact with Ogno.
